



DETERMINATION OF NON-SIGNIFICANCE (DNS)

Name of Proposal: Lake Tye Field Renovations

Description of Proposal: The Lake Tye Park All Weather Field Project proposes to convert an existing under-drained grass athletic field to resilient infilled synthetic turf. Lights will be added to expand hours of availability, and a variety of safety and security fencing and pedestrian access improvements are also proposed. The existing grass fields are irrigated and include a sand-based, under-drained profile. The overall site disturbance proposed is 5.05 acres. Lake Tye Park is approximately 20.54 acres and located in the Parks (P) zoning district.
